Comparative Conversations on Peace Education

Date: 10 December 2021

Venue: A virtual meeting online via Zoom (Central African Time Zone)

This workshop concludes an empirical investigation of whether and how Peace and Values Education (PVE) in Rwanda is informed by social science research and pedagogies that enable participants to navigate difficult, often sensitive, topics. After two Reflexive Review Workshops centred on the Rwandan context, this workshop seeks to broaden the debates by examining findings from Rwanda alongside broader theoretical and practical insights from other contexts. Building on existing peace education interventions by the Aegis Trust in the Central African Republic, the workshop will examine similarities and differences between the two contexts and explore possible lessons that can inform future practice in both contexts and beyond. The event will feature renowned global experts working in peace education as well as scholars and practitioners from Rwanda and CAR working in the field.
